C. Bill 1131

a. Senator Marrow: This is a Bill made from a Senate last year

i. WHEREAS the Associated Students' Government has been informed of the growing School of Nursing and has allocated representatives

ii. WHEREAS the 38th Senate allocated two of four At-Large positions to the School of Nursing, as well as suspended several functions of "Nursing Senators"

iii. WHEREAS cutting two voting Senator At-Large positions causes lack of student voice and involvement

iv. THEREFORE BE IT HEREBY ENACTED the two Senator At-Large positions will be reinstated effective immediately

v. THEREFORE BE IT HEREBY ENACTED the two Senator At-Large positions will retain all rights and responsibilities given to a regular Senator

vi. THEREFORE BE IT HEREBY ENACTED the filling of the two Senator At-Large positions will follow Policy Manual procedure
