**Brief statement of Program mission and goals:** Extended Studies offers a Bachelor of Science (BS) in Interdisciplinary Studies. An Interdisciplinary Studies degree allows the student to choose a major or concentration in more than one area and study the subjects and topics in which they are interested. It also allows for students to combine science with other interests such as business, psychology, humanities, or social science. A major in Interdisciplinary Studies provides a flexible degree that provides students a means to combine multiple majors for degree completion. This new range of skills for the workplace allows students to make connections between different ideas and concepts, which bolsters their critical thinking, ability to be creative when solving problems, and collaboration skills that are essential for their success in their careers.
