Comments on part I reporting:

Students assessed (not all of whom were nonprofit administration minors) met the goals of each SLO. The NPA minor curriculum was reorganized in 2023-24 due to ongoing low enrollments in the minor. Changes will go into effect in AY 2024-25 and provide a wider range of courses that students can take to fulfill the minor requirement (courses across the university are included). The minor is currently housed in the CHASS Dean's Office but given the low enrollments in the minor, the inclusion of courses from across the university in the minor and the need to provide more support for recruiting and retaining minors, the CHASS Dean will talk to the Center for Honors and Leadership about possibly moving the minor into that area. This should result in stronger recruiting of students who would benefit from the nonprofit administration minor as well as more focused administration of the minor, including assessment. The CHASS Dean will also work with the CHL to revise the assessment plan for the NPA minor.
