# J. <u>Regular Agenda</u>

- a. Student Tickets for NCAA Division II Football Playoffs
  - 1. (King) Motion to review agenda (Hulet seconds)
    - a. Zarr: Athletic control, they do not have student tickets. Asking President DiMara for tickets. 100 student tickets would cost \$500
  - 2. (Retzlaff) Motion to add course program to the agenda (Hulet Seconds)
  - 3. (Bartnett) Motion to approve the 100 tickets on the rollover (King seconds)
  - 4. Discussion points
    - a. Zarr: Athletic control, they do not have student tickets. Asking President DiMara for tickets. 100 student tickets would cost \$500
    - b. King: Additional amount of tickets that were retroactively paid last year.
    - c. Retzlaff: Will it be for this game or the next round too?
      - i. They may ask us. Only for this game.
    - d. Ball: Has it been a problem with the students who will be back?
      - i. Usually sold out but don't know if they have all been used
    - e. Retzlaff: Clarification, is it this week or the week we come back?
      - i. It is this week, the 21st
    - f. Hulet is excused; 6:45
    - g. Huerta: Approves for the tickets, the money will be there.
      - i. Can talk to Joe Folda to make sure
    - h. Retzlaff: Is the rollover for the money guaranteed?
    - i. Zarr: We got off topic and we should add to agenda.
      - i. Retzlaff: It may be an issue for students who do not have a place to stay or students who do not live near campus.
      - ii. Zarr: Agrees with Huerta and can verify.
      - iii. G. Wilson: If needed we can run an emergency meeting.
    - j. Barnett Motion to approve the 100 tickets on the condition that there is a rollover King
  - 5. Huerta Motions to vote by roll call Hulet seconds Vote passes 8-0-1
- b. Election Code Policy Manual Update Discussion
  - 1. Discussion points
    - a. Topic: G. Wilson: Length of campaign period, open for discussion.
    - b. King: There seemed to be a lot of issues with the topic.
      - i. Pro-temt Hulet returned 7:02
      - ii. Senator Olay: Excused at 7:03
    - c. Barnett: Only putting the campaign to a week.
    - d. Zarr: Social Media: campaigning up through date should be limited and private groups were considered an issue. As long as it's told then it shouldn't be an issue.

- i. Senator Olay re-entered at 7:05
- 2. Retzlaff: You can promote your own team but not say anything against the other team.
- 3. King: hard this to distinguish. Going to need to be really careful because it's a very grey area
- 4. Hulet: clarification should be key. Privacy may be deemed concerning.
- 5. G. Wilson: Non-professional or personal attacks should not be permitted to Hulet and Retzlaff's comments
- 6. Bartnett: Is there a way the voting committee still has access to it? No opposition to posting group.
- 7. Zarr: it's private and there should be no regulation
  - a. Concern was pre-election campaigning.
- 8. King: of course people will be campaigning before the actual campaign.
- 9. Huerta: If people do their own private message, it can stay out.
- 10. Gallery: people using the private group for their own campaigning because it's through invite.
- 11. Zarr: "The commission can't see if I'm pulling friends aside because it's a different way of going about it."
  - a. Gallery: It is not staying private
  - b. Zarr: doesn't understand why it has to be private. It's with their own team so it shouldn't matter.
- 12. Topic: G. Wilson: Judicial branch going under the dean of students
- 13. Zarr: Should there be a certain amount of money you could spend on your campaign the more you're invested is your dedication.
  - a. B. Wilson: No limitation for campaigning.
  - b. Barnett: Agrees. It won't be a lot of money.
  - c. Hulet: Agrees. One more thing the commission has to watch. There has to be some freedoms.
  - d. Olay: Has an issue. Ruling can be bought
  - e. Barnett: No random person will be pulled to do it.
  - f. G. Wilson: Senator Olay offers a valid point.
  - g. Zarr: May be rewriting it over break. Senators; read it and give tips.
  - h. Topic: G. Wilson: Course Fee
  - i. Zarr: Student Fee Governing Board. Approached by deans for course fees. Policies are set and need to be approved. Program fees are non-campus specific and course specific fees. Timeline needs to be submitted to provost by January  $1^{\rm st}$ .
  - j. Topic: G. Wilson: Approval for \$75 Enactus t-shirts
  - k. Zarr: Enactus: \$75 enactus t-shirts. Huerta and Ramos ordered shirts
    - i. Hulet: Are shirts for people in enactus?
      - 1. For anybody willing to help
