- 2. Childcare continues to be an operational burden to Auxiliary Functions that reduces funding for other efforts due to the need for continued subsidy. In addition to Auxiliary's fund transfer of \$116,592 to make this account whole, the Childcare center receives non-profit grants from private foundations to further subsidize their operations. The total subsidiary impact is well over \$200,000 for the Fiscal Year 2024.
- 3. Updates to the building, maintenance costs and important security updates will be required to continue this effort.
- 4. The childcare contract is expiring this year and if to be continued will require a RFP for the business. It is recommended that the RFP be written so that financial risk to the university be mitigated or eliminated.
