<u>Old Business</u>: Vicki Becker attended the State Liaison Council (SLC) Meeting on June 23, 2017 in Colorado Springs, CO. She reports there were 13-15 attendees from schools all over Colorado including Metropolitan State College Denver (\$3000), Colorado School of Mines(\$4000), Red Rocks Community College(\$0), Pikes Peak Community College(\$760), Arapahoe Community College(\$2000 Professional Development only). She inquired about Classified Staff Council Budgets (shown in parenthesis) to get an idea of what others have to work with each year. Networking with other CSC employees provided some ideas for fundraising (blood drive, basket raffle) and similar issues with employee engagement and losing Classified Staff positions.

The speaker was Kim Burgess, Director of Human Resources. There was discussion about step-pay versus performance pay with a midpoint goal for all employees. She mentioned the State going to a 5point evaluation system in the future.
