- If a student has been awarded Pell Grant funds:
  - The Pell Grant may be released for disbursement mid-semester if the student has completed **at least 50%** of all coursework for the term in which the student is enrolled.
  - If the student does not complete 100% of their coursework with a passing grade by the end of term in which the student is enrolled (see dates above) then the student is **no longer eligible** to receive the Pell Grant and the Pell Grant funds will not disburse or will be charged back to student's account.

Financial Aid award amounts are based on the enrollment status determined by the number of credits a student is enrolled in including correspondence and classroom/traditional courses (see chart below). If a student is enrolled solely in correspondence courses the cost of attendance and financial aid will be reduced to only include tuition and books.
