## Colorado State University-Pueblo Extended Studies – Independent Study Registration Policies

### Early Registration

Students who register during the early enrollment period will not be required to pay at the time of enrollment. As with on-campus classes, student (PAWS) accounts will be billed for courses the student enrolls in based on the published schedule. Students will be able to view their bill on PAWS after the billing date established on the published schedule. For students receiving financial aid, changes for Extended Studies courses will be settled on the student account prior to financial aid disbursement. Access to the courses for Early Registration will begin on the start date of the course. Students will not be able to access course materials prior to that date.

### Standard Registration

During the standard registration period students are required to provide payment at the time of registration. Course start and end dates will be based on the date of type of course and registration date. Please see the published schedule for start and end dates for each term.

### Drop for non-payment

Students who registered during early registration but have not satisfied their payment obligations by the payment due date for each term will be dropped from their enrolled courses. Non-payment for Extended Studies classes may also effect enrollment in on-campus classes as drops for non-payment are based on the total amount due on a student's account. A student may be reinstated by re-enrolling in the course with the payment due at the time of enrollment.

### Financial Aid Registration

No registration will be processed with financial aid as payment after the deadline date (12 weeks prior to the end of the term). **If registration is submitted after the Financial Aid Registration deadline, students must self-pay.**

When available, students using financial aid to pay for courses are required to enroll in the Learn by Term option for the course which provides additional support for students to complete their courses on time and complies with Financial Aid timelines for completion of the course within the traditional semester.

When Learn by Term options are not available, students using financial aid to pay for courses may enroll in Extended Learning courses, however they are required to complete their course work by the last day of the campus term in which they are enrolled in order to avoid financial aid penalties.
