To obtain a current copy of your Certificate of Eligibility, please log on to the e-benefits website at https://www.ebenefits.va.gov/ebenefits/homepage. Once you are logged in, click on "manage benefits" and look under the "education" tab. Under the "Education Tab," you will see "Post-9/11 GI Bill Enrollment Status"; print off the first page and that will work for a COE.

Residency Status

- Newly released from active-duty
 - o Bring a copy of your DD214 to the MVSC office and a copy of driver's license.
- Out-of-state without intent to change residency
 - CSU-Pueblo has the Yellow Ribbon program to help offset the cost of out-of-state tuition. The VA only pays the in state tuition rate. To qualify for this program you must

be eligible for 100% of your Post 9/11 (Chapter 33) educational benefits. The Yellow Ribbon form must be filled out at the beginning of each semester.

- Active-duty/Dependents
 - Pleases take the Military Tuition form to the Education Office on your military base and complete. Bring signed form back the Veterans Education Office at CSU-Pueblo. This form must be completed before the beginning of each semester.
