




Fair Labor Standards Act (FLSA)

Fall 2016 Freshman Admissions Info (as of 4-18-16)




Deposits are showing a very positive trend for this Fall.

In addition to actual deposits, responders to the Royall deposit IQ survey are indicating they will "probably" deposit at a higher rate than last year, by 20%+, and about 5% fewer are indicating they do NOT intend to deposit.

Royall Partnership Costs


Partnership began with a partial cycle in Feb 2014. First full year, services were expanded to include online apps, online payment options, and yield enhancement efforts.

Royall's Contributions to Freshman Admissions Efforts

The Royall partnership has year-round impact – Fall is the primary focus, but the benefit can be seen in all semesters. *Royall-initiated contacts were a large part of our Spring enrollment increases and look to be an even larger percentage of the Fall class.*

The Royall partnership also brings us a large percentage of our most academically gifted students, as can be seen in the Fall 2016 merit scholarship awards – **over 60%**.
