COVID-19 UPDATES

Effective May 26, CSU Pueblo returned to [full-in-person operations](#), retaining some hybrid services as needed. Campus is currently operating at full capacity, including in the Recreation Center, across athletics, and for all external events: camps, clinics, auxiliary services, and summer academic programming.

As of July 30, CSU Pueblo remains in active “outbreak” status, with our last, reported, positive case on July 23. As of this date, we have had 12 “breakthrough” cases among vaccinated individuals, though none has been hospitalized. Point-of-care testing continues at the Wolfpack Wellness Center. As of July 30, we have received over 823 https://www.csupueblo.edu/coronavirus/_doc/07-26-2021-students.pdf [voluntary vaccination records](#) from employees and students.

On July 26, a [joint communication](#) was sent to all CSU Pueblo students from the Executive VP for Academic Affairs and Provost, Dr. Mohamed Abdelrahman, and Dr. Chrissy Holliday, the VP for Enrollment Management, Communication, and Student Affairs, which detailed fall plans based on information available to leadership as of the date of the message.

DEVELOPING PEOPLE

Previously, when employees needed mediation services, CSU Pueblo would utilize The Colorado State Employee Assistance Program (CSEAP) resources. We heard from our employees that this organization was not meeting their needs, because the mediators sent to campus were not familiar with higher education at all. Our faculty and staff wanted access to experts who were familiar with higher education and, specifically, CSU Pueblo.

As the Employee Relations Specialist in Human Resources and Institutional Equity (HRIE), funded through VISION 2028, Jennifer Martin White wanted to fill this need for campus. Over the past four months, despite the challenges of COVID, Jennifer worked with legal counsel and our Title IX specialist to ensure the mediation program and training available met industry standards. HRIE paid for Jennifer to complete the [Phoenix Strategies, Inc. certification program](#).

From their website, “Since 1997, Phoenix Strategies has been a leader in alternative dispute resolution (ADR) services and training in Colorado Springs & Denver. Relationships are the heart of PSI’s conflict management services and training.” I learned the facilitative style of mediation which helps parties build relationships and come up with their own resolutions.

In July 2021, Jennifer Martin White completed the coursework and became a certified mediator for CSU Pueblo.

CREATING COMMUNITY
