Almost without exception, social service agencies which meet our requirements for practicum placements require background checks as well as alcohol and drug testing at the student's expense. These policies are the policies of the social services agencies throughout this area, not Colorado State University – Pueblo policies nor the Department of Social Work policies. Having a criminal history may limit or prohibit a student's ability to obtain a field placement as well as limit or prohibit employment in social service agencies following graduation with a BSW degree or licensure if applicable.

Agency Drug Testing and Credit Checks

Students applying to the MSW program should be aware that some field placements conduct drug tests and credit checks on students who apply for internship. Although the State of Colorado has passed legislation affirming that they will not prosecute citizens who are in possession of a specific amount of cannabis, allow citizens to grow a specific number of plants, and allow dispensaries to sell cannabis for medicinal and/or recreational use, employers may still deny employment based on a positive drug test for cannabis. Likewise, internship agencies may deny an internship placement based on a positive drug test, even for cannabis. Further, holding a medical marijuana card will not protect the student if there is a positive drug test for cannabis and students may still be denied placement.

If you are aware that you may have a positive drug test, please speak with the field coordinator or your academic advisor, as you may be denied field placement from area agencies. Please note that the Department of Social Work at Colorado State University-Pueblo does not set these policies. It is the agency who sets the policy based on preferences, funding source requirements, type of client served, and other reasons. We cannot force an agency to change their policy.

Whenever possible, we will try to find you a placement with an agency that does not drug test or does not conduct credit checks, but we cannot guarantee that any specific agency will accept a student for placement.
