Field Liasion

CSUP instructor who is with you each week in your seminar class

Field Instructor/Supervisor

Designated social work supervision at field agency

Learning Plan

Document where field activities and supervisor feedback are shared

Task Supervisor Non-social work supervision in an agency

Field Agency

CSUP approved agency where students complete required field hours

<u>Title IV-E</u>

Stipend program for students interested in pursuing work in child welfare

<u>Tevera</u>

Online learning management system for tracking learning plans, timesheets, and contracts

FIELD PROCESS & REQUIREMENTS

1.Complete all program requirements (BSW classes/Admission guidelines)

2. Register for Tevera, through a link that will come to your school email (\$203)

3. BSW: Obtain written/electron ic approval from advisor to participate in field

Use approved form in Tevera

4. Apply for field through to Tevera by February 7th, before scheduling an interview with the Field Coordinator

5. Schedule an interview with Field Coordinator by

February 7th, 2022

If you do not receive an invite to Tevera via school email (may go to junk) by November 19th please let Marisa know ASAP

What about the Field Placement??

During the interview with the field coordinator you will describe your ideal placement, future goals, and overall experiences thus far.

The BSW Field Coordinator will work to help you find an agency for which you may take a field placement, or you can suggest one of your own

Once you are notified of a tentative placement, you must reach out to the agency to set up an interview. If the agency accepts you, and you agree on placement, a contract must be signed via Tevera by the student and site supervisor, or the field placement is not secure. An additional contract is completed between the university and the agency.

"It is the student's responsibility to secure a field placement prior to the semester of enrollment. The Field Coordinator will make a reasonable effort to assist the student in securing a placement. It is not the Field Coordinator's responsibility, nor is it the responsibility of the Social Work Department or the University, to obtain a placement for the student. " (Department of Social Work, Field Manual, p. 33, 2018).

It is also the student's responsibility to fulfill obligations to the agency and field placement to successfully complete practicum. This includes any required background checks and drug tests.

FIELD PLACEMENT STRUCTURE & HOURS

Fall/Spring, 16 weeks, 15-16 hours per week, and begins each fall semester and runs through the spring semester.

Days/hours arranged between student and agency *Field seminar class weekly*

Placement is not guaranteed! Not following CSUP Social Work Department and agency policies and expectations can and will result in a removal from the agency/field program. If this were to occur, you will be counseled out of the social work program and profession.

Learn to identify and recognize your own and others' triggers, and how to work through them

STUDENTS IN THE BSW FIELD PROGRAM ARE CONSIDERED PROFESSIONALS

10 CHARACTERISTICS OF PROFESSIONALISM:

- 1. <u>APPEARANCE</u>: having a neat, clean, and context appropriate dress and hair style
- 2. <u>DEMEANOR</u>:politeness, confidence
- 3. <u>RELIABILITY</u>: turning in assignments on time, being prepared and ready for field/class, punctuality
- 4. <u>COMPETENCE</u>: doing your part to become knowledgeable about the field, classroom, community, and the issues with which you work. Research, Practice, and Policy are fundamental pieces of being a competent social worker.

5. <u>ETHICS</u>: becoming familiar with and seeking supervision when needed on the NASW Code of Ethics in the areas of: (1)Ethical responsibilities to clients, (2) Ethical responsibilities to colleagues, (3) Ethical responsibilities in practice settings, (4) Ethical responsibilities as professionals, (5) Ethical responsibilities to the field of Social Work, and (6) Ethical responsibilities to the broader society.

10 CHARACTERISTICS OF PROFESSIONALISM (continued):

6. <u>MAINTAINING POISE</u>: ability to keep poise even in difficult situations, ability to stay calm and factual, assertive communication is acceptable, passive aggressive and aggressive behavior is not.

7. <u>PHONE ETIQUETTE</u>: Identify yourself with full name, agency name and title when applicable. Be polite and do not dominate conversations.

8.<u>WRITTEN CORRESPONDENCE</u>: Keep letters and emails brief, structured, to the point and polite. Use spell-check and do not write in all capitals.

9. ORGANIZATIONAL SKILLS: Keep yourself and your work organized.

10. <u>ACCOUNTABILITY</u>: You are accountable for any actions you make at all times. Do not blame others, learn from situations and move on. Your education will be what you put into it. Give your best effort in all situations, if you need help communicate early.

 CSUP Social Work students are NOT allowed to transport clients

Insurance

- Provided through the university
- Liability/Workers Comp



Complete the SAFETY PLAN with supervisor & Keep a copy of the Disruption Plan

<u>Changes:</u> Some flexibility may be offered for individual situations

This will be explained in more detail during field onboarding, and changes will be shared with students as they occur.

Safety: Know and follow agency and state guidelines

There are no fully online placements at the BSW level

You will be required to do a field placement during COVID if you are in the program

CSUP & the majority of field placements mandate the vaccine

Title IV-E Child Welfare Stipend

Scholarship program for students who are interested in pursuing a career in child welfare

*Must complete field placement in child welfare *Must work in child welfare for a minimum of one year after

graduation, or

will be required to pay back the funds provided through the stipend
*Must attend fundamental classes during first semester of field
*Stipends typically cover 80"% of tuition for one year
*Interviews and recipient selection will take place in early Spring 2021
