#### **Residency Status**

702 Eligibility

- Separated in the last 3 years
  - Bring a copy of your DD214 (member 4) to the VEB office and a copy of driver's license.

#### GI Promise

- 1. Copy of DD-214 (member 4, long version, including items 23 through 30)
- 2. Colorado Driver's License or Colorado Identification Card
- 3. Choose one of the following documents showing your intent to be a resident of Colorado:
  - Complete, signed lease, or purchase of Colorado home
  - Colorado Income Tax Form 104
  - Current Pay Statement showing Colorado withholding tax (may not be student employment)

### Out-of-state without intent to change residency

CSU-Pueblo has the Yellow Ribbon program to help offset the cost of out-of- state tuition. The VA only pays the in state tuition rate. To qualify for this program you must be eligible for 100% of your Post 9/11 (Chapter 33) educational benefits. The Yellow Ribbon form must be filled out at the beginning of each semester.

## Active-duty/Dependents

Pleases take the Military Tuition Status form to the Education Office on your military instillation.
 Bring signed form back the admissions office at CSU-Pueblo (719) 549-2462. This form must be renewed annually.
